1. Evaluation(ITB 32)

1.1. Evaluation Criteria (ITB 32.4)

The Purchaser's evaluation of a bid may take into account, in addition to the Bid Price quoted in accordance with ITB Clause 14.8, one or more of the following factors as specified in ITB 32.2(e) and in BDS referring to ITB32.4, using the following criteria and methodologies.

- (a) Delivery schedule. (as per Incoterms specified in the BDS)

The Goods specified in the List of Goods are required to be delivered within the acceptable time range (after the earliest and before the final date, both dates inclusive) specified in Section VII, Schedule of Requirements. No credit will be given to deliveries before the earliest date, and bids offering delivery after the final date shall be treated as nonresponsive.

- (b) Deviation in payment schedule.

The SCC stipulates the payment schedule specified by the Purchaser. If a bid deviates from the schedule and offers alternative payment schedule, it shall be treated as nonresponsive

- (c) Availability in the Purchaser's Country of after sales services for equipment offered in the bid.

The supplier shall provide detailed description of after sales services available in the Purchaser's country for equipment offered in the bid.

If such services are not available yet in the Purchaser's country, a Bidder shall confirm, as requested in ITB Clause 17.2 (b) and BDS ITB Clause 17.2 (b), that it is or will be (if awarded the contract) represented by an Agent. If such bid is accepted, the documentary evidences on appointment of a qualified Agent shall be submitted within twenty eight (28) days from receipt of the notification of award. Failure to submit such evidences shall be constitute sufficient ground for the annulment of the Contract Award. In this event the Purchaser may award the contract to the next lowest evaluated Bidder as defined in ITB Clause 40.2.

An adjustment equal to the cost to the Purchaser of establishing the minimum service facilities and parts inventories, as outlined in BDS 32.4, if quoted separately, shall be added to the bid price, for evaluation purposes only.

2. Qualification (ITB 34)

2.1 Qualification Requirements (ITB 34.1)

After determining the lowest-evaluated bid in accordance with ITB 33.1, the Purchaser shall carry out the postqualification of the Bidder in accordance with ITB 34, using only the requirements specified. Requirements not included in the text below shall not be used in the evaluation of the Bidder's qualifications.

(a) If Bidder is Manufacturer:

(i) Financial Capability

The Bidder shall furnish documentary evidence that it is in a sound financial status.

The average turnover of the last 3 (three) years period shall be at least 277.000 Euro.

(ii) Experience and Technical Capacity

The Bidder shall furnish documentary evidence to demonstrate that it meets the following experience requirement(s):

a. Company registration document;

b. At list 2 (two) contracts each of minimum value 140.000 Euro, demonstrating that he has successfully supplied, installed and commissioned goods similar to the type specified in the "Schedule of Requirements", during the last 3 (three) years;

c. Further, the bidder should be in continuous business of manufacturing products similar to that specified in the schedule of requirements during the last three years prior to bid opening.

(iii) Documentary Evidence

The Bidder shall furnish documentary evidence to demonstrate that the Goods it offers meet the following usage requirement: *catalogues and or data sheets of the product*

(b) If Bidder is not manufacturer:

If a Bidder is not a manufacturer, but is offering the Goods on behalf of the Manufacturer under Manufacturer's Authorization Form (Section IV, Bidding Forms), the Bidder shall demonstrate the above qualifications (i), (ii), (iii) and for the (ii) b. the Bidder shall demonstrate that it has successfully completed at least two contracts *each of minimum value 110.000 Euro, for supplying, installing and commissioning goods similar to the type specified in the "Schedule of Requirements* in the past 3 (three) years.

The Bidder shall furnish the evidence to meet the qualification requirements specified in Para (i) above from the Manufacturer who has provided Manufacturer's Authorization for the goods offered in the bid.

In addition, the Schedule of Requirements, together with the Price Schedule, should serve as a basis in the event of quantity variation at the time of award of contract pursuant to ITB 37.1.

The date or period for delivery should be calculated from the date from which the Supplier's delivery obligations start (i.e., contract signature) and until goods are delivered in the Final destination.
