1 INTRODUCTION

1.1 Background

The Ministry of Agriculture, Rural Development and Water Administration of Albania (MARDWA) is implementing the Water Resources Irrigation Project (WRIP). The financing agencies are the World Bank (WB) and Swedish International Development Association (SIDA).

The overall development objective for WRIP is to increase the area under improved irrigation and drainage and in so doing, to establish the institutional basis for improved IWRM.

Implementation of the public hearing to discuss the Environmental Management Plan (ESMP) was based on World Bank policies (OP 4.12) and the incumbent environmental Albanian legislation.

The principle document of reference to enable the Consultant to prepare the Public Hearing Report for Leminot are the following:

1. The Updated Feasibility Study Report prepared by the Consultant - Joint Venture Renardet – Beta Studio – Hydrowater-Albania (Renardet et al)¹
2. The Environmental and Social Management Plan (ESMP) Report and the Abbreviated Resettlement Action Plan (ARAP) prepared by the Consultant COWI-CEIA

1.2 Leminot Scheme

The Administrative Unit of Pirc is part of Maliq Municipality of Korca County. The I&D scheme for Leminot falls within this municipality and takes water from the reservoir of the same name.

Works on the rehabilitation of the Leminot reservoir: the main source of water supply for the irrigation scheme; were completed in 2016. The work on the irrigation channels are scheduled to commence in 2017.

Currently, the low priority scheme when rehabilitated will provide irrigation to 450ha of agricultural land all by gravity. A summary of the proposed works is shown in Annex 1.

2 OBJECTIVE OF PUBLIC HEARING

Public consultation aims to first inform the public, decision makers and other interested parties, on the nature of the project. This is followed by information on potential environmental impacts and social and mitigation measures to reduce the identified negative impacts. Secondly, the consultation aims to promote community, decision makers and other parties concerned for giving their opinion on the effects of the project, the proposed mitigation measures, ideas for implementing the best efficiency of the management plans, etc., aiming to avoid as the greatest of routine meetings and replace them with realistic and efficient consultation. The Public Hearing is part of this consultation process.

The objective of the public hearing in this instance is to inform the public about the findings presented in the environmental and social management plan (ESMP) of Leminot scheme. This was prepared by COWI/CEIA during 2016 and 2017.

The public would also be informed by the Consultant, about the potential environmental impact, the environmental management plans of irrigation schemes, and the procedures for the ARAP, if necessary.

3 PUBLIC HEARING

3.1 Implementation Procedure

The ESMP is subject to the procedure of public consultations conducted in accordance with the operational policies of the World Bank (OP. 4.01). The purpose of the public consultations is to enable the access to contents of documents for normal members of the public, institutions and all other interested parties, and to assure the possibility of informing potential comments, questions and conclusions on their contents. Furthermore, the consultation process must satisfy the current Albanian legislation which includes:

- Law No. 8672, dated 26.10.2000, “On the Aarhus Convention Ratification on public right to information, to participate in decision-making and to have access to justice in environmental matters”;
- DCM No. 994, dated 02.07.2008, “Public Participation in Environmental Decision Making”;
- DCM No. 16, dated 04.01.2012, “On Public Access to environmental information”;
- DCM No. 247, dated 30.04.2014, “On the determination of the rules and requirements of the procedures for information and involvement of the public in environmental decision making”;
- Law No 119/2014, dated 18.09.2014, “On the right of information”;
- Law No 146/2014 – On Notification and Public Consultation” – regulates the process of notifying the public on drafting legislative work and other strategic national and local documents;

For the organization of the public hearing, announcements were initially made during the first week in May 2017 in the municipal authority of Maliq and specifically in the Administrative Unit or Pirq. On May 22 the announcement was made in the Albanian newspapers Panorama and Sot News.

On May 23, 2017 in municipal building was placed announcements informing the public for the purpose of the forthcoming public meeting on 24th May at the Meeting Hall in Pirq administrative unit at 11:00 hours

Detailed information on the access to the summary ESMP document and the possibility of the public to provide comments were also placed in various media. Copies of the correspondence to newspapers, the public notices and the announcement on the MARDWA web pages are included in Annex 2. In summary they are as follows:

- The MARDWA sent official letters (Figure 4-1 and Figure 4-2) to two newspapers namely "Panorama" and "SOT" new on 17th May 2017 – 7 days before date of public hearing ,
- Emails were also sent to these same newspapers on 22nd May 2017 – 2 days before the date of public hearing (Figure 4-4 and Figure 4-5).
- Newspaper advert placed in "SOT" news and "Panorama" (Figure 4-3)
- On the MARDWA website from 6th May – 17 days before date of public hearing (Figure 4-6).
- In notices placed on Municipal notices boards (Figure 4-7) 3 days before the date of the public hearing.

3.3 Meeting Participation

The participants that attended the meeting were asked to record their name, their position and contact number. The meeting was attended by more than 55 participants. Details of the participation list are contained in Annex 3 to this report. Photos from the meeting are included in Annex 4.

The meeting had a broad spectrum of different people in attendance, including the following:

3.4 Minutes of the Meeting

Venue: Meeting Hall Pirc administrative unit
Date: 24th May 2017
Start Time: 11:00 -12:30 hours
Organiser: Maliq Municipality with support from MARDWA

Background and Introductions

The announcement for public hearing was made by MARDWA and Maliq Municipality with the publication of notices on main public buildings in Maliq Municipality.

The meeting was opened by Chairman - Mr. Vaske Cinoku who noted the importance of reconstruction of irrigation schemes for rural area of Pirc administrative unit and the impact on social and economic life of farmers. He noted also that the rehabilitation works should not cause environmental and social problems.

Mrs Elida Xhuveli an irrigation specialist in MARDWA, informed the participants at the meeting on the Leminot scheme to be rehabilitated. Mrs Xhuveli provided the meeting attendees with information on the WRIP and discussed the most important assumptions of the Project in relation to irrigation and drainage taking into consideration the main design assumptions from the preliminary design

Mr. Bardhyl Qilimi presented the Environmental and Social Management Plan of Leminot scheme, focusing mainly on the positive and negative impacts on the environment, the procedures for resettlement if it will be necessary during the implementation of rehabilitation works etc. Mr Qilimi provided some information on the essence of the ESMP, presented the document's structure and characterized contents of particular chapters of the ESMP. Mr Qilimi then discussed the role of the ESMP within the framework of a contract for construction works on the stage of the bidding procedure and during performance of the works.

Mr Qilimi then provided a presentation. This is enclosed as Annex 5. The presentation focused mainly on the positive and negative impacts on the environment, gender issues, employment and the procedures for resettlement /compensation /grievance mechanisms, if it will be necessary during the implementation of rehabilitation works etc.

Mr Qilimi presented the goal and objectives of the meeting and a summary of the ESMP for Leminot scheme. He explained to the participants the important of their input and feedback regarding issues that can be generated by the project development from environmental point of view (health and accidental risks, issues for infrastructure damage, or barrier to existing access roads etc., pollution and contamination, social issues, giving the right importance to the gender, employment and needs for training.

The Chairman Deputy Mayor of Maliq, Mr. Vaske Cinoku then opened the meeting for discussion. He asked if there had been any letters received from members of the public or any stakeholders related to the proposed rehabilitation of the I&D scheme. He was informed that no letters were received.

Matters Arising

The Chairman then encouraged the meeting attendees to ask questions. Those questions and the answers (shown in boxes) are reported below. The main issues raised were concerning the environmental impact and are summarised as follows:

Mr. Kleanthi Minga from the administrative unit of Pirc asked about the layout of the Leminot scheme. He mentioned that the existing schemes passes through the middle of the village. Rehabilitation works can affect the network of canals. There is also sewer pipes and electricity cables passing through the same are. Therefore there is a risk of pollution from sewage and the health of the population. Also, damages to village infrastructure may occur. He added that the area is prone to land slips which can cause structural damage to homes. Therefore technical project authors have to collaborate with the community to avoid the above phenomena.

Mr. Qilimi said that the ESMP contains important information on the water quality and safeguarding against pollution and damage to property and human health. He directed the participants to Table 4.1 of the ESMP for mitigation measures, where are predicted all actions to avoid pollution and contamination, reaction for accidental damages, responsibilities etc. Mr Qilimi added that the ESMP advocates substantial monitoring of parameters (including water quality) throughout the construction and during the operation of the I&D scheme.

Mr Nexhip Merolli. Director of Water, Municipality Maliq added to this debate by stating that in some areas of Leminot village the sewage flows directly into the irrigation scheme of Leminot.causing pollution in the soil and agricultural crops during the irrigation process. Mr Merolli said that the construction of septic tanks in the affected areas at the same time as the planned rehabilitation works to minimise disruption, will be an important action for saving of the appropriate irrigation water quality.

Mr Qilimi repeated his answer that the ESMP contains important recommendations to mitigate against pollution. He added that the planned coordination of the sewage improvement with the irrigation rehabilitation works is a good idea. Mr Qillimi recommended that the Municipality, MARDWA and the Contractor (when appointed) should work closely together to streamline the overall improvements to the scheme and sewage network in Leminot village.

Mr Kujtim Kucka, Resident of Pirc Administrative Unit, raised the concern of the employment of residents during the rehabilitation works of irrigation scheme and the using water reservoir to other economic activities such as fishing, etc.

Mr Qilimi said that the ESMP contains important information on recommending the employment of local labour . A priority of the WRIP project overall is to reduce the amount of unemployment in the rural areas and to prevent migration of people of working age away from rural areas.

Mr. Dritan Bregu, a farmer raised the concern about the quality of rehabilitation works. Poor quality of work can cause decay in the channels and water can leak into the street causing pollution and flooding of land, etc. impacts in the groundwater etc. Therefore he proposed a careful project implementation and greater participation of the community in the rehabilitation works.

Mr Qilimi repeated his answer from before that was to Mr Merolli. The local government administration and the municipal authorities must work together to ensure that these specific homes are provided with septic tanks. This work should be timed to coincide with the works of the I&D scheme rehabilitation to limit the disruption caused. The ESMP, mitigation measures and monitoring program, is well focused on such issues, and respecting of it, is an obligation for construction firm. The local community should not only be employed in construction works, but the inhabitants should closely supervise the works and report any malfunction of works.

Mr Vaske Cinoku, Deputy Mayor of Devoll asked about the avoidance of adverse environmental phenomena. He proposed the participation of the community in supervision, by a local team. This team should participate also on preparation of environmental action plan by the reconstruction firm. He proposed the preparation of an agreement between the participants in the project and the local supervision team. Mr Cinoku was also supported in this question by Mrs Marinela Pere, Inspector in Maliq Municipality, Mr. Agim Zacellari, a Pensioner, Mr. Bashkim Mehmeti - Farmer, Mr. Alban Hoxhallari - Farmer etc.

Mr Qilimi said that local participation had already been discussed but he added that the ESMP (especially Table 4.1) provide many details on a mandatory arrangement with the Contractor in the Pre Construction phase following into the Construction phase, which outlines many plans that have to be provided. This includes the Traffic Management Plan, Waste Disposal Plan, various Method Statements for construction, etc. Mr Qilimi recommended that the local administrative units must work together with the municipality and MARDWA to have agreement in their requirements of the contractor.

Conclusions and closure

The meeting was closed after all answers to the questions had been provided. The wrap up and meeting closure was made by the Deputy Mayor Mr. Vaske Cinoku, Mrs. Lida Xhuveli, irrigation specialist of MARDWA and Mr Qilimi CEIA-COWI expert. Mr Qilimi summarised that the questions were mainly concerning pollution and ensuring local participation in the supervision of the works.

Mr Qilimi thanked the community for their participation, questions and issues raised on the project development and assured the participants that all their comments would be recorded and taken into consideration within the final ESMP document. Upon approval by MARDWA and the World Bank this report in hand on the public debate would be disclosed on the MARDWA and World Bank websites.

The meeting ended at 12:30 hours

4 ANNEXES

4.1 Annex 1 – Leminot I&D Scheme Particulars

4.1.1 Project Details

The Leminot I&D scheme rehabilitation can be classified as a Category B project under World Bank because the impact on human population or environmentally important areas is less adverse than those of Category A projects. The general impacts associated with the works are temporary during the construction stage; few, if any, are irreversible and all are site specific. The project outcome and the adopted mitigation measures employed will actually benefit the area for the future. Under Albanian law the contents of the ESMP can be adopted as a Preliminary EIA document as the rehabilitation project falls under the list of project types within Appendix 2 of the Albanian EIA law.

The Leminot I&D infrastructure is one of the better schemes in terms of condition and this is probably because approximately 5km of the right branch main canal and 0.5 km of the left branch main canal were rehabilitated in 2010. However, for the rest of the main canal on both the right branch and left branch, significant rehabilitation is required to enable the scheme to function as designed. Therefore, the condition of the present downstream irrigation infrastructure imposes a partial constraint on the original, current and future use of part of the scheme. Around 250ha are currently irrigated from the original design of 450ha all by gravity

The 300 ha gravity fed command area (right branch) is a narrow belt with N-S alignment spreads along the lower slopes of the hills that bordered the Cereshnikuti stream valley. Southward, parallel with the stream, it intersects Sovjani and Novosele villages. Towards the north is located another 50 ha area (left branch) served by the gravity system located nearby the Shqitas village.

The condition of the Leminot dam is considered to be fair and does not currently constrain the supply of water to the irrigation scheme. A total of 12.7 km of main irrigation channel on the right branch and 2.2 km on the left branch is planned to be rehabilitated.

4.1.2 Proposed Works covered under World Bank funding

The Updated Feasibility Study and more recently the Preliminary Design by JV Renardet et al provides details of the main rehabilitation works to be undertaken at the I&D scheme under review. After stakeholder consultation with JV Renardet et al) Leminot I&D scheme was chosen and confirmed by MARDWA.

This work will rehabilitate the entire gravity fed system with a total command area of 450ha. Rehabilitation works comprise of the following key points:

- Periodic lining and reinforcement of canal right branch which totals 12.7 km with replacement of 7 culverts, 4 pipe aqueduct crossing (4 siphons), 18 offtakes and 7 irrigation bridges.
- Periodic lining and reinforcement of canal left branch which totals 2.2km with replacement of 2 aqueduct crossings, 4 offtakes and 1 irrigation bridge.
- Lining of 1.7 km of minor secondary works of canals in the distribution network with a flow rate from 100 l/s
- Reconstruction of the intake immediately downstream of the dam outlet with sluice valve 550 mm;
- Reconstruction of the divider with two sluice gates 50x90cm
- Construction, supply and settings of steel gates 60x60; 50x60; 40x40 and cross regulation gate on the right and left branches.
- Construction supply and settings of culverts ($\varnothing=80\text{mm}$; $\varnothing=100\text{mm}$) pipe aqueducts crossing, and irrigation bridge on the right and left branches as mentioned above.
- Construction of 4 long crested weirs (duckbills)

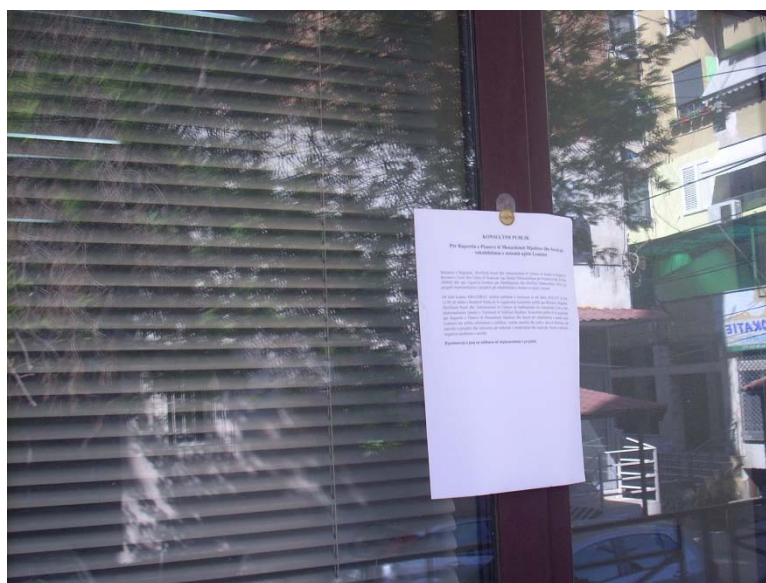
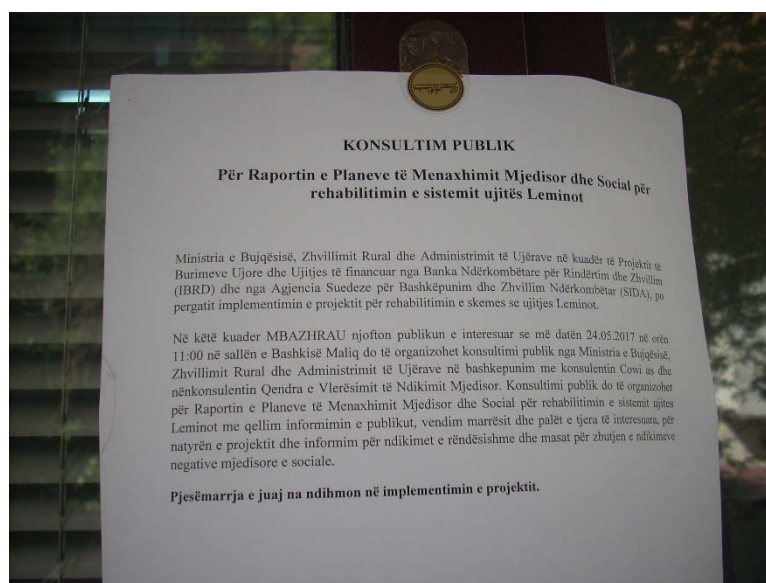
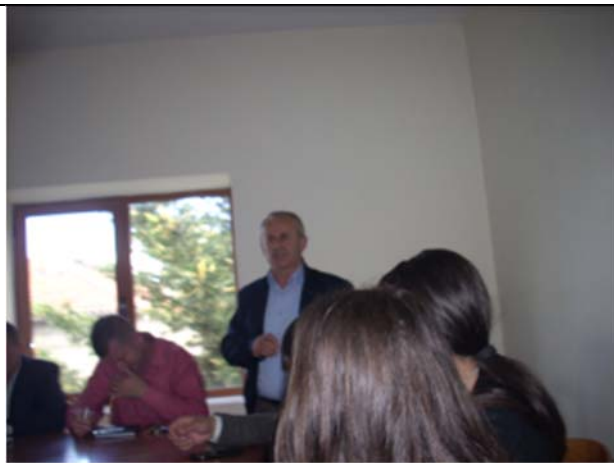


Figure 4-7: Public Notice in Maliq Municipality
