The Government of Albania has received financing from the World Bank toward the cost of the Water Resources Irrigation Project, and intends to apply part of the proceeds toward payments under the contract for rehabilitation of 5 irrigation schemes (location in Municipality of Lushnje, Divjaka, Roskovec, Devoll). Bidding process will be governed by the World Bank's rules and procedures."

The Ministry of Agriculture, Rural Development and Water Administration now invites sealed bids from eligible bidders for rehabilitation of 5 irrigation schemes (location in Municipality of Lushnje, Divjaka, Roskovec, Devoll). The number and identification of lots (contracts) comprising this bidding procedure are:

Lot 1 : Murriz Thana irrigation scheme – *Krutje Branch* command area 10,800 ha and 145 km main and secondary canal; and *Terbuf Branch* command area 4,180 ha and 107 km main and secondary canal.

Kurjan-Strum irrigation scheme - command area 4,730 ha and 88 km main and secondary canal.

Koshnica irrigation scheme - command area 350 ha and 20 km canal

<u>Lot 2:</u> Divjaka irrigation scheme – (*Divjaka northern and Divjaka southern irrigation scheme*), command area 2,630 ha, 22 km pipe line and 2 irrigation pumping stations. The

rehabilitation works on Divjaka southern irrigation scheme may be delayed by 6 months to 1 year time gap, depending on commencement and execution of work for rehabilitation of the Divjaka Dam
